 In planning Civil War Re-enactment, scheduled for June 13, 14, 15, 2014 at the Holcombe Jimison Farmstead, West Amwell Township, Hunterdon County. Budget: \$1,500.00 to be raised. This event will bring historical re-enactors to Hunterdon County for a three day event depicting daily life of Civil War Soldiers and families, how they lived, what they ate, how they survived, as well as re-enactments of battle skirmishes. Prior to the re-enactment, there will be a lecture by noted local historian and Hunterdon Civil War expert, John Kuhl who will discuss with the public what they will see and experience during the re-enactment weekend. The re-enactors will be accurately camping out at the Farmstead as they would have lived during the Civil War.

 Quilt Symposium, Display and Lecture: a 10 day display bringing together the most historical quilts from both the State of NJ as well as Hunterdon County. Budget \$5,000.00. Grant submitted for full amount on April 15, 2013. These antique quilts will be brought together for the first time in history under one roof at the Hunterdon County Complex. Docents will be available for the 10 days of the display from April 3 to April 13, 2014. On April 12, an all day Symposium on the history of quilting in Hunterdon County will be held at the Fellowship Hall of the Flemington Presbyterian Church where the attendees will be able to view the spectacular priceless Tiffany Stained Glass windows of the Church.

 Lindbergh Week: Budget: \$3,500.00 to be raised and offset with ticket sales to the Lindbergh One Man Show. Hunterdon County was put on the map in 1934 with the kidnapping of Charles Lindbergh, Jr. From April 26 to May 3, attendees will be able to tour the Lindbergh house and the site where the baby's body was found. There will be 3 different lectures given by noted Lindbergh author and expert, Jim Davison, who will discuss the theories on the kidnapping, the trial of Hauptmann, and the controversies surrounding Lindbergh's life. The week culminates with the presentation of a one-man show "Lucky Lindy" by Steve Carroll where the audience will be treated to a play revolving around Lindbergh's great accomplishment crossing the Atlantic in the Spirit of St. Louis, the kidnapping and his later years when he was allegedly a Nazi sympathizer. Mr. Carroll is adapting the production to include the audience and highlight the 300th anniversary of Hunterdon County. The production will be held in the Historic Court House where the actual trial took place and use the actual witness chair in which Lindbergh himself sat.
